**Promotion:** Win Beer for a Year

**Promoter:** The Redfern

**Promotional Period:**

Start date: Monday 1 November 12:00am

End date: Tuesday 30 November 11:59pm

**Eligible entrants:** Entry is only open to Australian residents who are 18 years and over.

**How to Enter:** To enter the Promotion, the entrant must complete the following steps during the Promotional Period:

a) visit the [theredfern.com.au](http://theredfern.com.au) website, follow the prompts to the Promotion entry page; and

b) fully complete and submit the online entry form with their personal details as requested and opt in *The Redfern's* mailing list.

**Entries permitted:** Only one (1) eligible entry per person will be accepted. By completing the entry method, the entrant will receive one (1) entry.

**Total Prize Pool:** AUD \$2,920.00

**Prize Description:** The prize in this giveaway is valued at \$2,920.00. The prize grants the winner one (1) schooner of 4 Pines beer a day for 365 days.

**Draw mechanism:** Digital entries are obtained via scanning a QR code and following the prompts. The winner will be determined at random.

**Winner notification:** The winner will be contacted by email or phone within five (5) days of the promotional period ending.

**Unclaimed Prizes:** In the event of an unclaimed prize, the Promoter may at its discretion assign the prize to another entry, draw at random. The Promoter is under no obligation to award any unclaimed prize.

### Terms and Conditions

The entrant agrees and acknowledges that they have read these Terms and Conditions and that entry into the Promotion is deemed to be acceptance of these Terms and Conditions.

The Promotion commences on the Start Date and ends on the End Date ("Promotional Period"). Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.

Valid and eligible entries will be accepted during the Promotional Period.

Employees (and the immediate family members) of agencies/companies directly associated with the conduct of this Promotion, the Promoter, its distributors, suppliers, subsidiary companies/businesses and associated companies and agencies are not eligible to enter. "Immediate family member" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

All reasonable attempts will be made to contact the winner.

If any winner chooses not to take their prize (or is unable to) or does not take or claim a prize by the time specified by the Promoter, or is unavailable, they forfeit the prize and the Promoter is not obliged to substitute the prize.

Rights for alcohol prizes will not be distributed by or to any person under 18, nor can a person under 18 dispense or collect an alcohol prize. Personal information collected from entrants will not be disclosed to any entity located outside of Australia.
